21 February 1945

On 19 February 1945 we bombed a target in Graz, Austria. After the bomb run, at approximately 1305, "Black O", flown by Lt. Damhorst, called "Black N", the lead aircraft in the formation, and said that he had one engine feathered and lost one turbo on another engine, and the other two engines were smoking. He also said that he was low on fuel and wanted advice as to what to do. Altitude at that time was approximately 21,000 feet. I told him the nearest field was approximately 130 miles away in Yugoslavia on a heading of about 190°. My advice to him was to call for fighter cover and drop out of the formation; attempt to reduce power settings as low as possible and jettison as much equipment as might be necessary to maintain altitude at his chosen power settings. He then replied he would attempt to do the best he could and thanked me for the advice. This was the last I heard from him.

At no time did I see any parachutes come out of the aircraft.

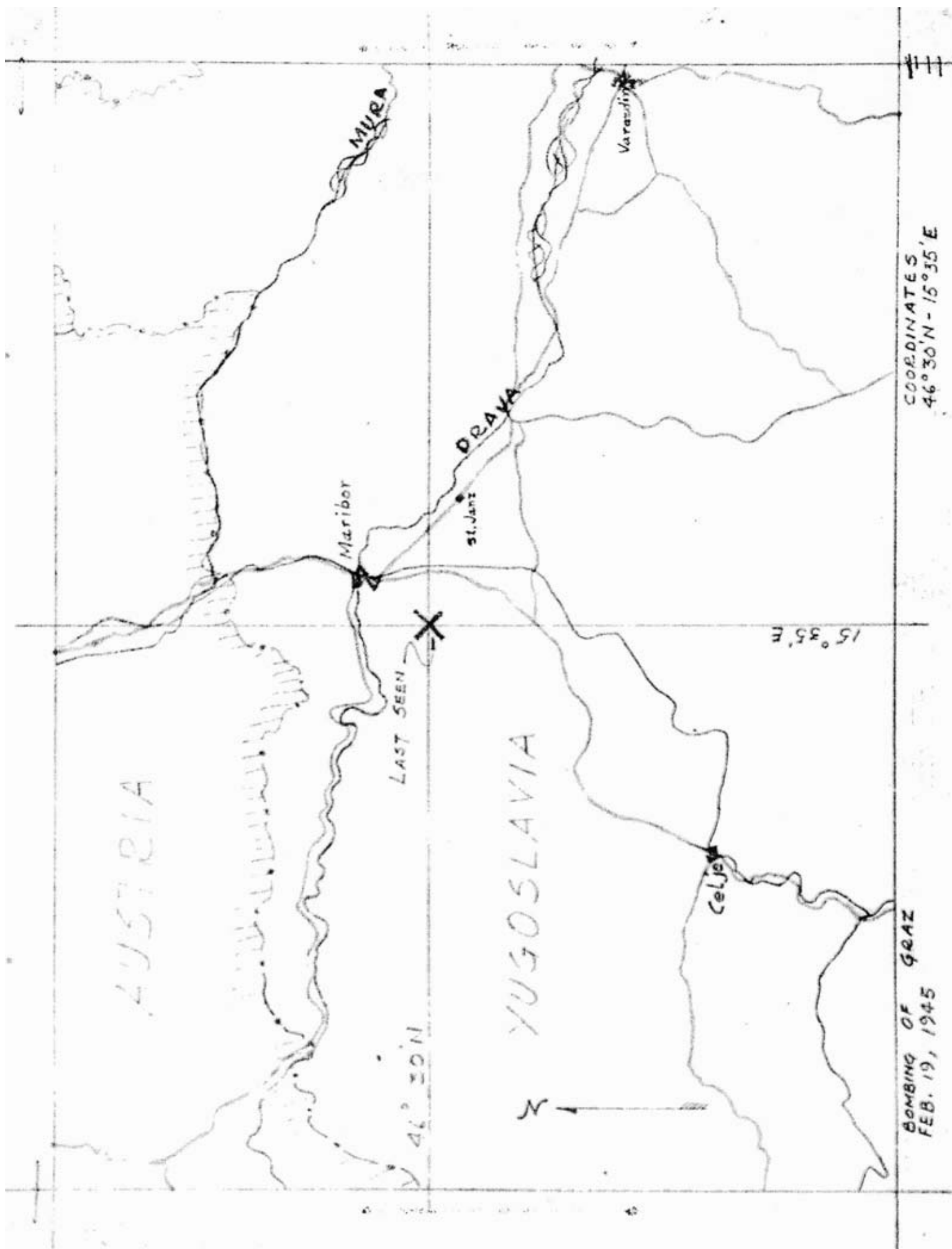

On the 19 February 1945, we bombed a target in Graz, Austria. After passing over the target at Graz "Black Oboe", flown by Lt Damhorst, turned off to the left with one engine feathered and we assumed that he headed toward the Russian lines. Apparently he was pulling quite a bit of power as his other engines were smoking some.

At no time did I see any parachutes come out of the aircraft.
